Benefits:

- Increases the academic focus of the Twilight Program. Students will study math and English daily.
- Able to implement a blended learning approach through the use of the school district's one-to-one initiative. This type of learning is currently being utilized by the majority of the Twilight instructors.
- Structured counseling and enrichment time will address emotional, social, academic and behavioral needs of students.
- Services within the school day will now be available to students: nurse, guidance, SAP, administration, school-based counseling, etc.
- Increases flexibility to meet the individual academic needs of specific students. For example, it may be possible to place a student in a block 3 class.
- Students will have the opportunity to eat both breakfast and lunch at school. The majority of Twilight students are on free and reduced lunch.
- Greater availability of guest speakers, mentors and agencies because program hours are closer aligned to a normal business schedule.
- Credit recovery for transfer students will be possible under a "Penn Manor Academy" model.

Online Academic Classes:**English:**

English teachers will differentiate instruction based off of students' abilities. They will utilize three computer-based programs.

Achieve 3000 focuses on nonfiction reading skills. Students take level set tests at the beginning of the program, and they read articles on their individual reading levels. The individual reading levels increase as each student experiences more success with the assessments provided by the program.

USA Test Prep focuses on both fiction and nonfiction reading skills. Students interact with tutorials and practice activities related to specific skills.

Study Island also focuses on both fiction and nonfiction reading skills. Students interact with lesson and practice activities related to specific skills.

Math:

During the online math instruction time, students will be utilizing School 21, which will prepare students for the Keystone Algebra 1 exam. By working on School 21, students develop skills and fluency with the type of problems that are on the Keystone Exam.

Science, Social Studies and Elective Courses:

These courses will utilize teacher generated resources and activities that will be disseminated via Moodle and Google Classroom.
