Blessing Mmugambi and Gertrude Moenga received National African American Recognition Awards; Maximillian Ponton received a National Hispanic Recognition Award; and Wyatt Rohrer received a National Indigenous Recognition Award. They are among 62,000 students from across the United States who earned the academic honors, which are designed to help improve college admissions among underrepresented student populations. WITF contacted the district for their *Brighter Days* videos. Beginning next week, a video highlighting bus driver, Roxy Carrigan, will be launched.
